#### Investment Objective

The Protected UK Index funds are designed to provide returns that are linked to the performance of the FTSE 100 index, whilst providing a defined level of capital protection (from 95% to 100%) each quarter. The aim of the funds is to provide investors with a means of accessing the UK equity investment market, without sacrificing their basic desire for capital protection.

#### How the Fund Works

At the start of each quarter a profit rate is declared for each fund. This determines the extent to which each fund will participate in any stock market growth. At the end of the quarter, the profit rate is multiplied by any growth to calculate the bonus for the period. This bonus is then added to the fund's protected amount to form the starting value for the following quarter.
