The change will be effective as of 2 April 2012.

For your information, the revised investment objective is as follows (the amendment is indicated in bold type):

To provide an **absolute** return of capital growth and income primarily through investment in a portfolio of bonds and other fixed and floating rate securities issued by governments, government agencies, supranational and corporate issuers in Asia excluding Japan. As part of its primary objective, the Fund also has the flexibility to implement long and short active currency positions either via currency forwards or via the above instruments.

The current Annual Management Charge will remain unchanged.

An updated prospectus for the fund can be obtained from your financial adviser or from the company upon request.

## What do I need to do?

If you are happy with the revised changes to the fund then you **do not need to do anything**. Your current holding will remain invested in the Schroder ISF Asian Bond Absolute Return Fund 'A' USD.

However, if you do not wish to continue investing in the fund you can choose to invest in any alternative fund within the available Preference fund range. Enclosed for your information is a copy of the latest fund performance bulletin which details the current range of funds available to you.
