The investment policy will be updated according to the change of name of the fund.

Janus Henderson have seen a declining interest in the fund's current strategy coupled with growing interest in income focused strategies. It has therefore decided that the fund's revised objective and strategy towards an income focus is a more compelling proposition going forward.
