Withdrawal of authorisation and termination of BGF Japan Small & Midcap Opportunities A2 Acc USD (the "Affected Investment Option") available under the Scheme Policy number – Preference (the "Scheme") <POLICY NUMBER>

Due to a lack of demand for the Affected Investment Option, RL360 has made the decision to i) terminate the Affected Investment Option pursuant to section 4 "Closure of Funds" of the Preference Policy Conditions, and ii) withdraw the Securities and Futures Commission (the "SFC") authorisation of the Affected Investment Option, both with effect from **11 January 2023**. Further investment into the Affected Investment Option, including top-ups and switches in, is not accepted from the date of this notice.

## Action required by policyholders with existing holdings in the Affected Investment Option

You are free to switch your existing holding in the Affected Investment Option to other investment options available under your Scheme free of charge. You may visit the interactive fund centre for your product at <a href="https://www.rl360.com/row/products/closed-products/preference/fundcentre.htm">www.rl360.com/row/products/closed-products/preference/fundcentre.htm</a>. Please note that our website contains investment options marked with '#' which are not available to Hong Kong policyholders. You will only be able to switch your existing holding to other investment options available under the Scheme which are available to Hong Kong policyholders. Once you have decided, complete the enclosed Fund Switch instruction form and return the same to us on or before 6 January 2023 by 16.00pm (Hong Kong time) by fax or post.

If we have not received your instruction to switch your existing holding out of the Affected Investment Option by on or before **6 January 2023** by 16.00pm (Hong Kong time), we will automatically switch all of your existing holdings in the Affected Investment Option into BGF US Dollar Reserve A2 Acc USD (the "Default Investment Option") free of charge on **9 January 2023**.

Any costs and expenses relating to the withdrawal of authorisation and termination of the Affected Investment Option will be borne by RL360.

## **Default Investment Option**

The underlying fund corresponding to the Default Investment Option is the BlackRock Global Funds – US Dollar Reserve Fund, which is a money market fund denominated in the same currency as your policy. The investment option has been selected because we do not have any investment options which are of similar investment objective and policy to the Affected Investment Option and the Default Investment Option has the lowest level of risk from the other available investment options. Please see below details of the Affected Investment Option and the Default Investment Option:
